Complete and submit to the College Point Yacht Club via USPS or email to CPYCmail@gmail.com. In addition, you must attach copies of the following:

- Boat registration or Certificate of Documentation
- Boat owners .Drivers license or valid ID
- Boat insurance ID card or proof of insurance

The rate for storage is \$65.00 per foot plus \$150.00 dollars for environmental costs. Plus 8.875% sales tax. Payment must be made by check or credit card. Credit cards will pay an additional 3% service charge.

Payment must be received, in full, prior to being hauled - no exceptions will be granted.

The Yard Master at any time prior to hauling (even upon arrival at the Marina/slings) for any reason can refuse the hauling/storage of your vessel. At the **Yard Master's** discretion an additional security deposit may be required based on the vessel's condition or value. If storage is denied, any funds already remitted will be refunded within 5 business days.

All Boats must be ready to launch by May 15, 2026. Any boat that must be relocated to allow the launch of other vessels will be charged a \$250.00 relocation fee. Any boat still on land after May 31, 2026 will be charged \$25.00 per day for summer storage. The area around your boat must be cleaned up by the boat owner on the day of your launch.

If you sell your boat, at any time during the storage period, **You** are responsible for any additional storage fees until the boat is launched or removed from the College Point Yacht Club.

Boat owners must provide their own means of entry to and from their boats, ie., ladders, platforms, and shall keep same and hold harmless the College Point Yacht Club from any and all liability arriving from and out of boat owners use of premises to enter, clean; repair or otherwise perform any duties on their boats. The boat owner will also assume all liability for any of its agents, servants or invitees.

It is expressly understood and agreed that in the event the boat, its contents and/or equipment are lost or damaged through theft, fire, vandalism or act. of god, the College Point Yacht Club shall not be liable to the owner for such loss or damage.

I Hereby Agree to remain personally responsible for any and all debts, costs, fees, monies, etc. due the College Point Yacht dub for the storage of my vessel including but not limited to past due storage, court fees, attorney fees and the full cost of the disposal of the vessel, in accordance with all applicable regulations and environmental guidelines
